### 4. FIRST AID MEASURES

#### SMALL SPILLS

#### LARGE SPILLS

Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). ### 7. HANDLING AND STORAGE
